Terms and Conditions:

- 1) **\$400 deposit** is required at the time of booking and is non-refundable unless location can be rebooked for the same price. Remaining balance due one week prior, depending upon number of total guests. Retail charge may be transferred to an *alternate date, based on availability*. It is understood and agreed to by both parties that the client shall be responsible for any and all damages to property, which may reasonably be attributed to the group. Damages will be charged accordingly.
- 2) It is understood and agreed to by both parties that the group will abide by any and all of the Lakeside Park Association's rules and regulations and/or instructions of LPA staff personnel. Lakeside Park & Lakeside Beach Grill reserve the right to re-schedule location assignments when an emergency situation occurs that can harm a guest. Lakeside Park & Lakeside Beach Grill is not responsible for lost of stolen articles.
- 3) All Decorations provided by the client must have prior approval of Lakeside Park & Lakeside Beach Grill. Items shall not be affixed in any manner to walls, doors, ceilings or fixtures. Tape or wire is ok to use. Throwing of rice, birdseed, confetti, silk/plastic rose petals, or releasing helium balloons are prohibited due to possible harm to the wildlife and birds. Minimal Rose or Flower petals are allowed. If used in excess and requires additional clean up for staff, an additional \$200.00 charge will apply.

- 4) All printed material or advertising using Lakeside Park Association, Lakeside Beach Grill or Weddings at Lakeside Beach and logos must have prior approval by same. Wedding invitations do not need approval.
- 5) Persons under 21 will not be allowed Alcoholic Beverages.
Alcoholic Beverages are not allowed at the Lakeside Beach Wedding Location.
Smoking is prohibited at the Lakeside Beach Ceremony Location.
- 6) **GUARANTEE:** *A guaranteed Guest Count must be received 7 days prior to event. This Guaranteed Guest count will be considered the minimum for which you will be charged, even if fewer guests attend. If paying by credit card, cash or cashier's check, payment must be made 7 days prior with final count, at which time an estimated bill will be presented.*
- 7) All functions will be subject to one master bill. Individual payments cannot be accepted.
- 8) Lakeside Park Association & Lakeside Beach Grill reserves the right to discontinue any music that disturbs our other guests. We ask that all music be kept to an acceptable level in consideration of all of our guests.
- 9) In consideration for the use of Lakeside Beach or Lakeside Beach Grill, or Weddings at Lakeside Beach, the undersigned agrees to indemnify and defend Lakeside park Association and its officers, employees and agents harmless from any and all claims, demands, causes of action or liabilities, arising out of injuries to or the death of any person. Also to include injury or damage to any property arising from the use of such property.
- 10) Horse drawn carriages or horses without carriage must have a diaper on to avoid unsightly occasions. Any horse not wearing a diaper, the client will be charged \$200.00 cleanup fee.
- 11) Delivery times for vendors: 30 minutes prior to a ceremony at the Wedding location.
- 12) I hereby grant to Lakeside Park Association the irrevocable and unrestricted right to use and publish photographs of me, my wedding, or in which I maybe included, for Bridal publications, electronic reproductions (web sites) and/or promotional materials or any other purpose and in any manner or medium. In addition, I grant my permission to alter the same without restrictions; and to copyright the same. I hereby release the photographer, Lakeside Beach Grill, Weddings at Lakeside Beach from all claims and liability relating to said photographs.
